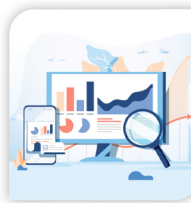
- Care coordination staff of RNs and LPNs communicate, engage and monitor patients via tele health platform to follow physician-approved care plan.
